Minutes of the CLIMATE & ECOLOGY SUB-COMMITTEE held on MONDAY 5TH JUNE 2023 at The Almonry, High Street, Battle at 2pm

- **1.** Apologies for absence Cllr A Barton.
- 2. Disclosure of Interest None.
- 3. Minutes of the previous meeting held on 15th May 2023 agreed and signed.
- **4. Meeting protocol** it was confirmed that only members of this Committee may vote. It was agreed not to be bound by standing orders in order for all members to speak freely.
- 5. Applications for membership to C&E Sub Committee none.
- **6. Reviewed Terms of Reference** members agreed to change frequency of meeting from monthly **as stated on the terms of reference to no less than four times per year**. Task and Finish Groups noted as a means to complete tasks

- A Teams meeting re Local Government Association's Greenhouse Gas Accounting tool is on 16th
 June, to start analysing the Council's carbon footprint.
- It has been proposed that the Council declare a Climate and Ecological Emergency. This has been added to the agenda for discussion at the next Full Council Meeting on 20th June.

8. Battle Civil Parish Carbon Footprint Change Target Report

The report includes the combined input from the feedback received from the group. Which areas the group would now focus on was discussed and how it can maximise impact; identifying what is within the Council's control and making these areas a priority for the Sub-committee.

It was agreed that the Council continues to **demonstrate and share good practice and progress we're making**, through embedding and addressing the importance of the climate and ecological emergency situation through each of its standing committee; specifically, through the objectives making up the **four-year plan**, and **highlighting activity where it is incorporated into council activity in order to influence.**

The Sub-Committee agreed selected areas for action and will chose task and finish groups to agree where it can influence most in more than one direction: i.e. residents, community groups, at town council level and at district and county levels.

Investigation of thermal imaging and evidence gathering was noted as being an important first step to encourage residents to take on half the responsibility as well as there being a **need for facts and statistics in order to resolve problems at source.**

Clir Burton, Clir Wheeler, D Wilson and S Bannon will create and circulate remits for each Task and Finish group to take forward:
